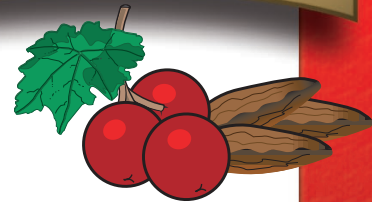

### DIRECTIONS

Prior to using these towels, test a small obscure area of the problem fabric, carpet, or upholstery for colorfastness, bleed, or color change. Allow to dry and examine.

When removing a stain or spot with these Towels, it is best to always work from the outside edge of the stain or spot towards the center to prevent it from spreading. Continue blotting action as long as there is visual evidence of stain transfer onto the towel.

### FOR SPILLS, SPOTS & STAINS

1. Remove any excess residue.
2. Pull towel from container.
3. Apply towel to any remaining spill/spot/stain in a blotting motion until removed.
4. Continue to apply until spot/stain is removed.
5. Using an absorbent towel such as a terry cloth towel, blot excess moisture until dry.
6. Be sure to close container cap tightly after use and before storing.
7. Wash hands thoroughly with soap and water.
