A heavy duty cleaner and limited disinfectant which is effective against gram negative bacteria when used on precleaned, non-porous, hard environmental surfaces. When used for industrial cleaning and disinfecting follow the directions below.

**For use in:** schools, colleges, universities, hotels, motels, office buildings, manufacturing facilities, retail businesses, athletic and recreational facilities.

**For use on:** walls, floors, doors, tables, sinks, stoves, restroom fixtures, telephone booths, and garbage cans.

**DISINFECTION:** Preclean all surfaces prior to disinfection. Apply use solution, 4 1/2 ounces per gallon of water, thoroughly wetting surfaces with a cloth, mop, or sponge. Treated surfaces must remain wet for 10 minutes. All surfaces to air dry. Fresh solution should be prepared daily and more often if solution becomes diluted or soiled.

### FOR LIGHT CLEANING AND DEODORIZING:

Use 2 ounces Heavy Duty Cleaner & Disinfectant per gallon of water and follow the same procedure as for disinfecting.
